Thank you to all the ladies that turned in hours for September. I just want to clarify a few points on using the WUFOO program in order to report your hours. Someone asked what is WUFOO. WUFOO is program we use in JWL to collect data through electronic fillable forms. Then these forms download into a spreadsheet that allows us to quickly tabulate data, which in my case is the number of hours reported. It is the same thing you used when you ordered your t-shirt. We have one that is specifically for reporting credit and hours. The reason this is helpful to you is that you will get a confirmation email everytime you report hours. That's a good thing because it will help you keep track of what you have reported and what you haven't yet reported, because we all know there are times this can get confusing. I respectfully ask that everyone bear in mind that I do have to keep a monthly total of hours reported, so it helps me a lot if you try and report on a regular or somewhat regular basis. Monthly is great, but if you forget to do it one month try and report the following month. This is a courtesy that makes my life easier, and perhaps might make yours easier too. You can open the WUFOO form and then send it to your home screen on your phone or ipad. That's a great way to keep that link handy. Next month I will be doing a drawing for a bottle of wine out of the people who make at least one report to WUFOO during the next month. So if you haven't reported on WUFOO yet then now is the time to give it a try. You might just earn a bottle of wine. For those of you who are reporting regularly I want to thank you very much. ## Project Chair (Tiffany Harvey & Courtney Strzinek)

The Gala Committee has been hard at work this month promoting Gala, securing sponsorships, selling tickets, and procuring auction items. Highlights include:

- Thank you to our committee and JWL members for their efforts on securing sponsorships, table/lounge sales, and ad sales this month! As of September 24th, the following have been secured: 1 Auction Sponsor, 1 Cigar Lounge Sponsor, 2 Gold Sponsors, 1 Silver Sponsor, 2 Double Lounge Sponsors, 5 Table Sponsors, and 8 Program Ads (separate from those already included in sponsorships). Also, 67 individual tickets have been sold, and multiple auction items donated. 11 comp tickets and 4 comp ads were given to our models/stylists from the Gala Style Shoot as thanks for their time. Our total revenue to date is \$19,965. We are still actively pursuing a Title Sponsor.
- Gala T-Shirts are in production; 58 were ordered at this time (42 were pre-ordered by Members and 16 will be sold to the public at our upcoming promotional events). This was a small fundraiser, bringing in \$183.42 in projected revenue if all public shirts are sold.
- 424 Save The Dates were mailed to all Honorary & Sustaining Members.
- We had a successful promotional event at Enid Pride on September 16th; upcoming events include First Friday at RE on October 6th, and the Community Cultural Celebration on October 7th. A Press Release has been sent to the Enid News & Eagle, and we are working to include our event on all Event Listings in the area. We also appeared on Community Talk on September 27th. Please let us know of any further Marketing/PR opportunities.
