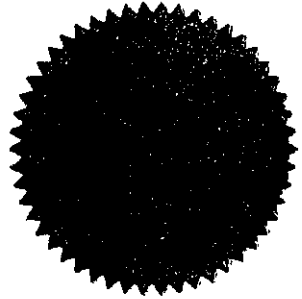

- (B) To purchase, acquire, hold, own, mortgage, lease and sell such property, real and personal, as may be deemed necessary.
- (C) To receive gifts and bequests of property, both real and personal.
- (D) To raise funds by solicitation or engaging in enterprises for such general purpose, provided however, no property or funds of the corporation shall ever be used for the aid or benefit of any of the members thereof.
- (E) To sue and be sued in its corporate name and capacity and to do generally such things as may be convenient to carry out the general purpose as above set out.
