Our deadline is November 15 and this process goes much smoother when we don't have to wait for people last-minute. You can reach out to the company directly if you have a relationship with them, just make sure that you tell me you have contacted them so we don't have conflicting messages.

Remember that you are responsible for securing \$200 in any combination of sponsorships, ads, auction donations, or ticket sales to fulfill your Credit & Hours requirements. If you have not met this requirement yet (according to the records from completed online forms), you should have received an email from this last week. It is important that we all fulfill this minimum requirement to ensure that we have the greatest success with this event. There will not be an opportunity to make this up following Gala. If you need help making your contacts or have had trouble securing/getting in touch with your people, let me know and we can work together to help you get this checked off. Invitations have been printed and will be mailed this week (before general meeting). We mailed almost 1,400 invites to local individuals and businesses who have various levels of involvement with JWL. We are no longer selling seated tickets to this event. There will still be a few requests and we are holding the very limited remaining seats for the last-minute accomodations. We have maxed out our seating at 41 tables! We have two lounges available and unlimited General Admission tickets, so encourage your friends and family to join us, even without having a guaranteed seat. There will be several bistro tables scattered around the room for our General Admission guests. I am passing around the volunteer schedule for Gala so you can begin to plan your Gala weekend. This is based off your responses last month and the needs of the event. More information related to Gala weekend responsibilities will be shared at our December meeting. If your scheduling needs have changed since you preffed last month, let me know and we will work around

whatever we need to. Last month, I gave everyone the heads up that you will need to arrive on-time to Gala and will be asked to help mingle with our guests as they arrive so we can put our best foot forward as an organization. This will help check off a good chunk of people for the auction staff as well as give us a good showing when guests start to arrive. Care to Share has a total of 26 hours to report for the month of October. We have assisted 12 schools and 49 students from Hennessey, Lahoma, Waukomis, Pioneer, Chisholm Prairie View, Carver, Coolidge, Eisenhower, EHS, Emmerson, &Waller. A total of \$1789.73 was spent on Clothing, Coats, Shoes, Socks, Under Garments, Hygiene Items, and school supplies. Hennessey had a family in dire need. The children were wearing the same clothing to school every day. There were 4 kids living in the home. Care to share supplied each child with 4 outfits, a coat, shoes, and under garments. We also helped Hennessey with hygiene items for their 6-8th grade girls. (10 Students)
